Your signature at the end of this contract is also an authorization for any emergency medical treatment while in my care. All vet fees are the responsibility of the owner.

All dogs must be current on vaccinations. It is the owner's responsibility to inform handler when vaccinations are due. Life and health insurance are the responsibility of the owner.

Duties of the Handler and terms of contract:

1. The handler agrees to present your dog in a professional manner, with both handler and dog being well groomed. Proper housing, exercise, sanitation and feeding will be provided. Every safety precaution will be taken while traveling to and from shows.
2. If there is a ring conflict, it is up to the discretion of the handler to determine which dog she will show and to have another competent handler show the other dog.
3. Unless owner specifies otherwise, photos will be taken when the dog wins first point, first major and a new champion. All charges for photos will be the responsibility of the owner.
4. Group ring- A mutual agreement will be made with individual client in advance of entering group ring.
5. Fees are as follows:
 - Shipping charges to and from handler are the responsibility of the owner.
 - Board for each dog is \$ 8.00 per day.
 - All entry fees are the responsibility of the owner. A credit card number is the preferred method for the handler to make entries.
 - Dogs will be taken to handling class for training. The number of classes attended will be determined by handler based on the progress of the dog. Charges for class will not exceed \$40 for six class sessions. If other client's dogs are attending class with handler, charges will be divided by the number of dogs attending.
 - All travel expenses (motel, gas, parking etc.) will be divided by the number of dogs traveling to and from shows.
 - Fee for showing the dog each day is \$50. If for some reason dog can not be shown but was taken to the dog show, the fee still applies.
 - Fee for showing in group is \$25.
 - A \$500 retainer is required when dog is shipped to the handler, unless other arrangements have been made. Final payment will be deducted from retainer and balance will be refunded to the owner.
 - All payments are due upon receipt.

Karen Conti will not be liable for the following: Loss or damage from disease, accident or death. Injuries to a person, injury to or from another dog, or destruction of property.

It is agreed upon that the fees incurred under this contract will be due according to the terms outlined. I understand that this is a legal and binding contract and agree to the terms above.
